- Rachel has sent out the English Athletics (EA) Fees. She has had bounce back e-mails from Angels, Almost Athletes, Cirencester and Cotswold all runners. She has had no EA fees from Cotswold All runners for some time now. Also no fees from Forest of Dean, Running Somewhere Else, Tewkesbury All Runners and Stroud.
- Rachel had to travel to Coventry to the nearest Virgin Money bank. This is far from ideal.

6. Road Race Secretary's Report

Phil presented his report as follows:

We are halfway through the road race series for 2024 (Bourton One Mile, Stroud Beer Race and Fairford 10k having been completed since April) and a number of competitors are meeting the 5-race qualifying criteria. Remaining races listed below:

We have dates for all of the remaining races, with entries to be opened for three of these.

With the Linda Franks Race to be dropped from the series calendar from 2025, two potential replacements are being considered. The Dymock 5-mile and a to-be-confirmed 4-miler hosted by Dursley RC, likely to take place in October. Of these, the 4-mile race would be preferable, primarily due to the date.

Due to the takeover, and planned work at, Berkeley power station, the Berkeley 10k race is in jeopardy. I suspect that the Fission 20-mile race may also be in the same position and will contact Rogue Races to determine what their plans are for 2025.

• Cranham entries open at the end of June.

7. County Track and Field Championships Part 1 Review

Arthur presented the following report:

- The EA survey of athletes are still being analysed and the officials one closed before any
 officials could reply. We had delays in publishing the timetable but had a good number of
 officials. I've not counted the entries but it was similar to last year's. It may have been a
 good decision not to combine with Avon AA as they had quite large fields and made separate
 arrangements for hurdles and some other events.
- It is easy as Chair to take on organising roles but I will not in 2025 be co-ordinating the working group that organises Part 1.

8. Any Other Business

• The sad passing of Dave Lucas was announced. Funeral details to follow.

- There is an extra layer of available support for athlete's welfare. Welfare is different to safeguarding. Safeguarding is more policies. Welfare is more holistic spreads wider. Every club must have a Safeguarding Officer. Some clubs have both Welfare and Safeguarding Officers. Welfare Officers are optional.
